General Conditions

1. The annual service fee payable under this agreement is non-refundable and will not be pro-rated if this agreement is terminated for any reason.
2. This Agreement is being offered to you because you are now or have indicated you will become, a regular customer of Polsinello Fuels, Inc. (“PFI”). If during the Contract Period you, or the person to whom this agreement is assigned, ceases to be a regular customer of PFI, PFI may terminate this agreement.
3. This agreement covers only the air conditioning equipment located at the residence set forth in your enrollment form. Only one unit per contract.
4. This agreement may be transferred to a new owner of the residence as described in your enrollment form—provided the new owner complies with all the terms and conditions of this agreement.
5. PFI may terminate this agreement if the equipment covered hereunder becomes unserviceable or if your account with PFI becomes thirty (30) or more days delinquent without any refund.
6. PFI shall have the right to inspect the equipment covered hereunder prior to its acceptance of this agreement and reserve the right to decline acceptance after such inspection.
7. Charges for services performed by PFI prior to its acceptance of this agreement are not included hereunder and shall be timely paid for by the contract holder.
8. This agreement does not include the cost of labor or materials for repair or replacement when the failure of the equipment is due to acts of God, fire, water in basement, defects in piping system, defects in duct work or homeowner caused problems.
9. PFI’s obligation to furnish parts under this agreement is subject to the availability of such parts through normal sources of supply.
10. PFI shall not be liable for any loss, damage or injury caused by failure or delay in performing services hereunder when such failure or delay arises out of causes beyond PFI’s control. Nor shall PFI be liable for any other loss, damage or injury arising hereunder unless caused by its negligence.
11. This agreement contains the entire understanding between the consumer and PFI relating to the subject matter hereof.

General Conditions for Total Cooling Comfort Air Conditioning Plans

- Annual tune-up of system is included. Tune-up will be performed in conjunction with heating system tune-up, if possible.
- All labor charges for system repairs during normal working hours are included, unless excluded within this agreement.
- Any pre-existing service conditions will be billed at prevailing rates.
- Accounts must be approved for credit and current with established credit terms.

This agreement is for residential equipment up to 5 tons (60,000 BTUs)

All tune-ups will be performed Monday through Friday during normal working hours. Tune-up must be performed within the contract period. There will be absolutely no refunds, however the Agreement may be transferred to a new homeowner of the same property location.

Contract Period

This agreement does not become effective until paid in full and inspected by Polsinello Fuels and will continue in effect for one year from date of issue unless cancelled by either party with 30 days advanced written notice. This agreement will be automatically renewed unless otherwise notified in writing by the customer. Prices are subject to change on a yearly basis.
